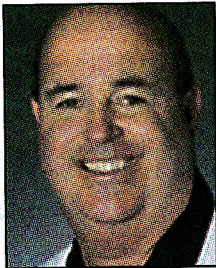

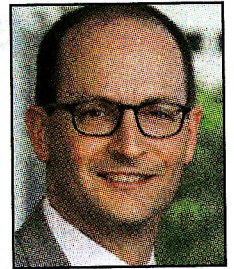

Cantey Hanger LLP named **Michael Appleman** as vice chairman, Tax Practice Group. Appleman is a third-generation Fort Worth attorney.

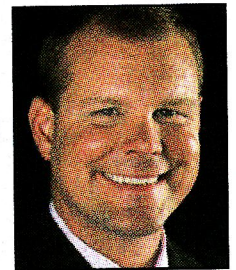
